

Mining is one of the five sub-sectors that constitute the Environment and Natural Resources Sector. Mining is identified in Vision 2020 as one of the key sectors to be developed to expand the economic base and exports. The Ministry of Natural Resources is responsible for designing the sub sector's legal framework and also for granting prospecting, exploration and mining licences. Rwanda Natural Resources through the Geology and Mining Department provides technical and administrative support and follow-up to the performance of the mining sector and generally to implement policy. The mining policy covers not only mineral extraction, processing and export, but also quarrying, production of construction materials and extraction and processing of semi-precious stones.

The Mining sub-sector is one of the major sources of income to the country with revenue from minerals exportation. The new mining law and related ministerial decrees were published and a new mining policy was adopted by Cabinet.
